#### CHII D FIND

Child Find is the process of locating, identifying, and evaluating all students 3 years of age but less than 22 years of age, who are in need of special education services and related services, regardless of the severity of their disability.

G-CCSC will be conducting a Child Find for children ages 3-4 (not yet 5 years old on or before August 1, 2019) during Kindergarten Round-Up. You may attend any scheduled Round-Up listed. Preschool staff and Speech and Language Pathologists will be conducting FREE screenings at each elementary school during the Kindergarten Round-Up times listed above.
